### Where have we got to?

Welcome to the latest edition of Highbarns News, bringing you up-to-date on what has happened so far, what is currently happening, and what will happen next.



We have several new teams of people in place who have been appointed in the last few months to bring the project to a successful conclusion. Shane Flynn, Assistant Director (Finance and Resources), has taken over from Steve Baker as the Council's lead on co-ordinating the project now that we have secured funding and are moving on to repairing the mine.

Mark Skittrall, who addressed the public meeting in February, remains the lead for Hyder, our technical consultants and project managers. You'll find contact details for both of them, as well as other useful contacts, at the end of this newsletter.

### Investigation of the ground

Following the agreement of funding from the Homes and Communities Agency, Hyder undertook to manage the project in two stages:

- Stage 1 Ground investigation works to check the extent of the mine and to work out how much repair work is needed
- Stage 2 Remediation works to fill the cavities, repair the mine and to remove the blight to the area caused by the presence of the mine

In February, Vinci were appointed to complete Stage 1 and they have been working quickly to capture all the information needed, using probes to provide a picture of the extent of the mine. This required a huge amount of co-operation from everyone concerned and those working at the site are very grateful for all the help and co-operation that you have given so far, despite a changing picture which has often meant extra work and unexpected short-term changes to plans.

The investigations have progressed well and all the signs are very positive. This phase of the work is due to be completed by the beginning of June.

Please be advised that there are six boreholes located around the edges of the site. These contain groundwater monitoring standpipes. Other boreholes will remain in place for CCTV camera surveys to be undertaken when necessary. For each of these boreholes a lockable steel cover has been fitted and concreted into place, flush with the ground surface. These will remain in place until all works are completed.

### What happens next?

Following their work on Stage 1, Vinci will now clear away all of their equipment and temporary buildings from the site. Hyder will analyse all of the information and design a scheme for treating the mine, which will take until September. We will then appoint a contractor to carry out Stage 2.

You should see site buildings returning towards the beginning of December, and work will start then. There will be a two week break over Christmas, but work will continue throughout the winter and should take about 16 weeks.

The treatment site works should be complete by late April 2013 - as long as there are no unforeseen hold ups or problems - while reinstatement works and removal of the site cabins should be complete by late May 2013.

These photos are taken from a similar set of works on chalk mines found in another part of the country. Our aim here in Dacorum is to achieve the same results by returning everything to normal once the works are completed.


### How will you be affected?

The Stage 2 contractors will draw up a plan to make sure that they can repair the mine in the simplest, quickest and most secure way. As soon as they have developed their plans to a point where they can be certain about timings, we will let you know which houses will be affected by the work and what actions need to be taken to secure each site. Heavy machinery will be needed but, as with the investigation works, everything will be returned to its original condition as soon as the works are completed.

The last activity will involve checking that the work has been successful. This will require access inside homes to ensure that stability has been achieved so that validation reports can be provided. Again, all the costs of this work have been budgeted for in the funding bid, and everything will be returned to normal once the tests have been completed.

It will be necessary for those living in properties affected by the works to move out for the short period that work is being carried out underneath the premises. If you are affected, we will aim to provide notice of the need to vacate your property one month before the work is due to start, but please note that in the early stages of the work, shorter notice may be given. You may want to begin thinking about what arrangements you might be able to make with family and friends.

We will be gathering information about the needs of all residents affected over the summer and will arrange a public meeting to discuss the proposals when we get a clearer picture of what will be required and when.



### More information

We will continue to publish newsletters for the remainder of the project and will also be seeking to use local notice boards and public events to keep you informed and provide opportunities for you to put questions to all those involved in the project. In the autumn we will set up regular drop-in sessions for local residents so that there will be a dedicated time and place for questions and answers at least once every week.
